Regulation

Charles & Dean Finance is a trading name of Charles & Dean Ltd who are an independent finance brokerage with a selected panel of lenders. We are authorised and regulated by the Financial Conduct Authority. Our Firm Reference Number is 653592. We are permitted to act as a Credit Broker. Charles and Dean Ltd is a credit broker and not a lender and operates with a panel of lenders from whom we are paid a varying commission, based on either fixed or rate to risk models.

Our Services

We offer our services to you which include:

- arranging finance with a funder for you after you have agreed the cost and funders charges (or the basis of such costs if they cannot be determined in advance)
- preparing and witnessing appropriate loan documentation on behalf of the funder. We are not linked to any of our lending panel members. We recognise it is important for customers to be able to shop around for credit and alternative sources of credit. Some of the services that we provide are not regulated by the Financial Conduct Authority. You will be advised in advance of any such proposal or service.

Quotations

We will quote figures based on our funders' cost of funds. The funder has the right to change or decline these quotes on receipt of the full proposal. A lender may conduct a soft credit check and a hard credit check, prior to completion of the finance application. Further details will be available from the chosen lenders Privacy Notice or Terms and Conditions.

Our Remuneration

We do not charge you a fee for our service. We are remunerated by way of an introductory payment, payable by the funder. The nature of this payment and the effect on the interest rate you might pay will vary from funder to funder and is dependent upon a number of factors including (but not exclusive to) asset type, product chosen and customer circumstances. We do not take credit for payments due until the funding has been paid out. Once the most appropriate funder for your needs has been selected from our panel, the exact amount of commission we receive will be disclosed to you in good time, and before you enter into the finance agreement. If you were referred to us by an Appointed Representative, an Introducer Appointed Representative, or a Supplier with whom we hold a commercial relationship, we will also pay them a commission.

Conflicts of Interest

If through exceptional circumstances Charles & Dean Ltd or any of its Directors or other customers has a material interest in business you ask to be transacted for you, we will make you aware of the conflict of interest and we will obtain your consent before your instructions are carried out.
